Sealed Bids for the installation of sidewalk within the Township, **GFA Project No. 24014** will be received, by **the Charter Township of Union**, at their office located at **2010 South Lincoln Road, Mt Pleasant, MI 48858**, until **1:00 PM** local time on **May 22, 2024** at which time the Bids received will be publicly opened and read. Funding for this project is through Charter Township of Union. The Project consists of:

2024 Bud Street Sidewalk Extension Project

The construction of approximately 634 linear feet of 6 foot wide, ADA compliant, barrier free, concrete sidewalk from Pickard Road to Jameson Park, along with driveway removal and replacements, and lawn restoration.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, with additive alternate bid items as indicated in the Bid Form.

Upon request and receipt of the payment indicated above plus a non-refundable shipping charge **if the bidder has requested "Overnight" shipping**, the Issuing Office will transmit the Bidding Documents via delivery service. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

Alternatively, Bidding Documents are also available on compact disc or through a File Sharing site (as portable document format (PDF) files) for a non-refundable charge of **\$25**, including shipping via overnight express service.

Fax transmittals of Bids or Bid bonds will not be accepted.

The Owner reserves the right to waive any informalities or to reject any or all Bids.

No Bidder may withdraw their Bid within 90 days after the actual date of Bid opening.
