2. The City has available locations for stockpiling, mobilization and disposal of excavation materials. Contractor shall be responsible to coordinate and all associated costs including but not limited to labor and transport.

3.) If the decision of the Administrator is not favorable, an interested party may appeal directly to the Administrative Review Board (formerly the Wage Appeals Board). Write to:
